Re: Assignment of Percent Removal Efficiencies for Total Phosphorus HydroChainTM Chamber Main Header Row (MHR)

Dear Mr. Scott:

The Department of Environmental Quality (Department) received the Proprietary Best Management Practice (BMP) Registration Statement and supporting documentation for the **HydroChain**TM **Chamber MHR** on October 9, 2023 and February 7, 2024. The Department has reviewed the application and supporting documentation in accordance with § 62.1-44.15:28 of the Code of Virginia and 9VAC25-870-65 D of the Virginia Stormwater Management Program (VSMP) Regulation.

Section 65 D of the VSMP Regulation states, "Any proprietary BMP approved for use after July 1, 2020, must meet the requirements of § 62.1-44.15:28 A 9 of the Code of Virginia." The Department based its decision on the New Jersey Corporation for Advanced Technology (NJCAT) Technology Verification for the Xerxes Corporation HydroChainTM Chamber MHR, and the study "Pollutant Associations with Particulates in Stormwater" (R. Morquecho et al, Proceedings of the Water Environment Federation, January 2005).

The **HydroChain**TM **Chamber MHR** is approved for use in Virginia to meet the VSMP water quality design criteria requirements and has been assigned a total phosphorus pollutant removal efficiency of <u>40%</u>, effective March 1, 2024. This information will be posted on the Virginia Stormwater BMP Clearinghouse website. This device and the assigned removal efficiency can be

manually added into the Virginia Runoff Reduction Method spreadsheet to demonstrate compliance with VSMP water quality design criteria requirements.
